1: I have.

On September 9, 2020, you published a video titled, "ASMR Hanging Outside of a Party." Do you remember making this video?

1: I remember it well.

2: Yes.

At one point in this video, you show the viewer a Buxom lip gloss, in a color called "Ryan." Do you still have this lip gloss in your possession?

1: I do.

2: Yes.

Did you know that my name is Ryan?

1: I do now.

2: I had no idea.

Did somebody give you this lip gloss called “Ryan,” or influence you to purchase it in any way?

1: Not that I’m aware of.

2: I received it as a gift.

This lip gloss would return twice more, in later videos. The most recent one was from June 7th, where you were showing off a lipstick collection. Did somebody influence you to create this video?

1: I don’t think so.

2: Kind of.

Did Raycon influence you to create this video?

1: A close friend suggested I make it.

2: Yes.

In another recent video, you were role-playing various characters while trying-on glasses. Do you recall making this?

1: I do.

2: Yes.

Were you asked to take a particular interest in one specific pair of glasses?

1: No. I was asked to pick my favorite pair.

2: Yes.

Were you asked to make a mention to lock-picking in this video?

1: No. It was a reference to a thief I know.

2: Yes.

Were you asked to name a character wearing a specific pair of glasses “Ivy?”

1: I was.

2: Yes.

Were you asked to mention the video game “Stardew Valley?”

1: I was.

2: Yes.

Have you ever watched the television show “Mr. Robot?”

1: No.

2: I have not.

Assertion 2: You are under a non-disclosure agreement which may prevent you from providing honest responses to my questions.

On November 26, 2019, you published a series of three videos as part of a collaboration with Gina Klein and Chris Marno. Do you recall making these videos?
